

**5. INFORMATIONAL ITEMS**

- a. Report from the WRA Chair: Bill acknowledged the passing of Vice-Chair, Cecilia Curry's father and offered condolences. Tim O'Halloran will participate in a session on groundwater management and legislation at the upcoming fall ACWA conference in December.

**6. UPDATE ON WATER LEGISLATION & REGULATORY ISSUES**

- a. Delta Update and FloodProtect: Cindy Tuttle last reported that FloodProtect completed a Regional Flood Management Plan (RFMP) and submitted a request to DWR to fund the next phase of the RFMP to implement components of the Plan. They are also moving forward with the Integrated Water Management Plan (IWMP). This is a multi-benefit project from the RFMP that incorporates fish, flood and farming. They also completed the Yolo County Flood Governance Study and gave a presentation to the Yolo County Board of Supervisors in October. - b. Legislation and Regulatory Update: David Guy, NCWA, gave this update.
  - Voters passed both Proposition 1 and 2 at the November election. David gave a brief overview of what Proposition 1 will fund. Bi-partisan legislative support for both propositions was unprecedented.
  - The Governor's California Water Action Plan will provide the framework for continued discussions in 2015. David anticipates the administration will use this Plan to prioritize the State's budget and the implementation of Proposition 1.
  - Drought discussions will likely continue into the new year.
  - David explained how the State Water Resources Control Board (SWRCB) is proceeding on a new track this year regarding water right curtailments and their real-time response to winter storm events. NCWA in conjunction with MBK Engineers, has been advocating lifting the ban on pre-1954 curtailments as agricultural system demand decreases in November. The SWRCB responded by lifting 1914-1954 water right curtailments. This allows water users to move water in the system into storage. Ideally NCWA would like to get all curtailments lifted. Even if curtailment is lifted, Term 91 (water rights after 1965) is still in effect for those who are subject to it. David acknowledged the SWRCB is trying to be flexible knowing that water will be needed next year.

Lewis Bair, Reclamation District (RD) 108, gave an update on Propositions 1's impact on local storage projects. RD 108 is one of the seven agencies on the Sites Project JPA (<http://sitesjpa.net/>). Sites was uniquely named in the California Water Action Plan as the type of implementation agency that would benefit from Prop. 1. Prop. 1 has \$2.7 billion allocated for public benefit storage projects – surface water and groundwater. Potential projects will go through a defined public process to certify funding eligibility. Typically storage projects have multiple beneficiaries yet only the water users pay for the project. It is anticipated that a portion of the Sites Project will be funded under Prop. 1. This public benefit project will provide ½ million acre-feet of water annually, in addition to cold-water pool, recreation and flood control benefits. If Sites is built, there will be a large amount of water available to help improve Northern California environmental conditions. This would in turn

further insulate RD 108's water supplies. As the cost of water rises (~\$500/ac-ft), he anticipates that more Northern California water users will invest in the Sites Project. Sites JPA agencies are identifying locally preferred projects/alternatives and the potential impacts of other planning efforts. A report will be published with this information. Extensive outreach has also been conducted with local landowners. The next step would be to meet with investors from a variety of groups, i.e. agencies, non-governmental organizations. Lewis answered questions.

**7. WRA TECHNICAL COMMITTEE (TC) UPDATE**

a. Technical Committee (TC) Activities and Westside IRWMP Update: Elisa Sabatini, TC Chair, reported that the TC has good member agency participation including a few new TC representatives. In 2015, the TC will be reviewing our adopted documents that will also help the newer members familiarize themselves with the Yolo County and Westside IRWMP. Since so much of our focus has been on drought and groundwater, it will give a more holistic view of the WRA's regional efforts. Chair Marble added that we are not intending to re-write the Yolo County IRWMP, but it is appropriate for us to refocus on our priorities for Yolo County. With the advent of the Westside IRWMP as the prime regional planning document, this 2015 focus will be an overall strategic planning process rather than re-writing a technical document.

**8. The "YEAR of GROUNDWATER",** Tim O'Halloran, Yolo County Flood Control & WCD; Gary Bardini, Deputy Director Integrated Water Management, California Dept. of Water Resources

a. Groundwater Legislation: Tim informed that today's discussion is a follow-up to the November Board meeting's preliminary discussions regarding the new groundwater legislation. Today he would like to focus in more detail on the role and responsibilities of the Groundwater Sustainability Agency (GSA). Tim acknowledged two groups that the WRA invited to today's meeting that are integral to the groundwater management discussion: the Yolo County Farm Bureau and the Yolo County Landowners Association. Participation of the private landowners will be a key component to successful implementation of the groundwater legislation in conjunction with the WRA's member agencies.

To frame today's discussions, Tim asked David Guy to give a summary of a NCWA meeting held earlier today on this topic. A larger regional group of Sacramento Valley water managers (8 counties), as well as, several DWR senior staff members discussed how to effectively implement the legislation to represent how groundwater should be managed to benefit local agencies and the region. A successful outcome would be a sustainable groundwater supply and everyone expressed commitment to this end. Tim reiterated that Yolo County is well-organized and has been effectively managing our groundwater for many years.

Tim gave an overview of the groundwater legislation presentation that he has given at least 15 times around Yolo County over the last few months. (Tim's PowerPoint presentation can be viewed at: [www.yolowra.org/meeting\\_directors.html](http://www.yolowra.org/meeting_directors.html).) He highlighted two points: the GSA is to be formed by a local agency or a combination of local agencies and the GSA is required to develop a Groundwater Sustainability Plan (GSP). There are two notable timelines: GSA formation by July 1, 2017 and GSP development by January 31, 2020.

The previous work and outreach conducted in Yolo County over the last few decades had put us in a strong position of pro-active groundwater management. Beginning in January, the WRA will

start discussing the harder questions about who should be the GSA and whether our groundwater is sustainable - has it been and will it continue to be. The choice of whether the WRA could be the GSA hinges on answering these questions. If our groundwater is sustainable, then it may not be critical who the GSA will be. If we determine our groundwater is not sustainable, then the authorities and responsibilities of the GSA are more crucial. Tim read directly from Chapter 5 of the legislation on the Powers and Authorities. The GSA may conduct an investigation for the purposes to:

- 1) Determine the need for groundwater management
- 2) Prepare and adopt a GSP and implement rules and regulations
- 3) Propose and update fees
- 4) Monitor compliance and enforcement

He then read the additional authorities of the GSA from Chapter 5 that may extend to regulation of groundwater extraction. Tim is well aware that this groundwater legislation language will raise concerns for many well owners. The legislation was written with the intention of local governance, but if a GSA is not established then the State will step in to manage. The legislation mandates that it has to be a local agency or a group of local agencies. Tim restated that if we can ascertain that Yolo County groundwater usage is sustainable already, then none of these regulations will have to be implemented.

Tim proposed that the WRA member agencies acknowledge their support for the following, *“The WRA, in coordination with the Yolo County Farm Bureau, will act as the planning forum for determining what agency or agencies will serve as the Groundwater Sustainability Agency (GSA).”* Tim opened the floor for discussion and questions. The following addition was suggested to the above proposal after the Yolo County Farm Bureau: *“and other interested parties,”*. The WRA may ask for letters of support for this proposal from its members. Tim offered to draft a sample letter or resolution for the January Board meeting. The Board discussed what changes the WRA may need to make to its organizational structure to become the GSA. Gary Bardini offered input on the questions raised. Tim gave an example of how the Regional Water Authority convenes as the Sacramento Groundwater Authority (a separate entity) to conduct business related to their groundwater management planning. This is a question that will need additional discussion.

Gary Bardini, DWR, began with some background to provide context for the groundwater legislation and then will discuss details about the legislation itself and its implementation. He first acknowledged the great foundation that Yolo County has established with the WRA's membership and stakeholders for two decades. He distinguished that the legislation is not really about sustainable “groundwater”, but about sustainable “water management”. Gary gave a brief historical overview of how water legislation and management deliberations began in the early 1900's. At that time, they chose to focus on surface water and water rights. Recent water conditions and drought impacts lead to the push for the current groundwater legislation. He reviewed the State's adopted Water Action Plan that also laid the foundation for prioritizing water issues. The legislation has four phases: establishing/identifying the institutions to manage, developing a sustainability plan, reviewing all the plans from a statewide perspective to coordinate management strategies (a DWR task), and ongoing progress toward sustainability through identifying water supply options, projects/programs and effectiveness of dealing with

authority issues. This whole process will likely take more than 20 years. Lastly Gary discussed implementation of the legislation. He introduced David Gutierrez who has been asked to take a leadership role in the management of this process. He has experience in a variety of executive DWR positions and has a clear understanding of state water management. Currently they are in the initial planning phase and securing the budget needed to move forward.

There are several strategies for supporting the legislation's implementation:

- Providing facilitation or other services to assist with formation of the GSAs
- Utilizing the existing State data programs and technical evaluation like CASGEM
- Providing planning assistance under the Bulletin 118 statewide groundwater program
- Providing additional financial assistance under Proposition 1
- Providing inter-regional water planning assistance

Next Gary discussed more specifics about the assistance to be provided for the initial GSA formation. He explained the groundwater basin priority ranking set by DWR to comply with the groundwater legislation that simple identifies how reliant a basin is on groundwater. The second issue being resolved is the basin boundary definition. Currently the boundaries are defined by Bulletin 118. He briefly explained the definition parameters. DWR will be flexible with local input to consider how these boundaries may need to be adjusted to satisfy some regional needs. Concern has been expressed as to what will comprise the Groundwater Sustainability Plan, since many AB3030 have already been adopted. Discussions will be held with the practitioners with a stakeholder process to resolve any issues. Gary reviewed the legislation deadlines and answered questions. Question topics included basin boundary changes/timeline, multiple agencies wanting to become the GSA, possibility of a sub-agency within the GSA, how will small non-WRA agencies that purvey water participate in the process, method of sharing best practices statewide as the process is developing, concern that the WRA will become a regulatory focused agency and lose the collaborative forum established that fosters valuable work on projects and sharing of information.

Chair Marble asked the Board for their input and opinions on information presented and next steps for action. Each Board member weighed in with their opinion about the formation of the GSA and the WRA's potential role. Consensus was that a detailed conversation should continue with the inclusion of broader outreach to other agencies/stakeholders in the county. The proposal of the WRA, the Yolo County Farm Bureau and other interested parties acting as the planning forum for determining the GSA was supported by the Board. Another suggestion was to hire facilitation assistance for the planning forum so that the WRA chair can fully participate. Chair Marble stated that this conversation will continue at the January WRA Board meeting. He invited each of the WRA representatives to return to their respective Boards and codify today's information to garner support of the planning process using Tim's proposed statement.

**9. PRESENTATION: Local Drought-related Projects**

- City of Winters Water Re-use: Cecilia Curry summarized this project. The City was approached by a local landowner that is in close proximity to their wastewater treatment plant who was interested in utilizing secondary water for his prune orchard. Permits had been difficult to secure prior to the drought, but they were finally able to acquire one and the re-use project has been successful with this landowner.
- City of Woodland Water Recycling: Tim Busch reported that the City is in the early stages of implementing the water recycling program. The City secured \$2 million grant funding through the Prop. 84 Drought Solicitation under the Westside IRWMP/WRA to fund this program. They are in the process of planning, designing and permitting the project so they can start construction in April 2015 for completion by the end of 2015. Tim detailed the targeted uses for the recycled water and water conservation/cost savings that will be realized. - YCFC&WCD Drought Preparedness Canal Modernization: Tim O'Halloran reported that the District also secured \$2 million grant funding through the Prop. 84 Drought Solicitation under the Westside IRWMP/WRA for their canal modernization program. Tim explained how this is an extension of the Winters canal modernization project.

Tim and Max will be attending an Irrigated Lands Program meeting in December to discuss items related to the Year of Groundwater.

**5. Update on Water Legislation & Regulatory Issues**

Tim informed that two groundwater bills have been introduced by Senator Pavley. One is a “fix it” bill to clean up grammar and language in the adopted legislation. The other is an adjudication bill. Neither bill is significant for Yolo County. The WRA should continue to monitor the storage component of Proposition 1 and make sure it has the support of Yolo County (aka Sites JPA/RD108). The remainder of Proposition 1’s funding aspect still needs to be clarified in 2015. Tim will be presenting a series of four workshops this week on the Groundwater Sustainability Agency (GSA) to continue educational outreach. The WRA has received a couple of inquiries about the draft proposal language that Tim introduced at the November WRA Board meeting regarding the WRA’s role in the planning forum to identify a GSA. He feels we still have time to clarify the proposal prior to requesting any definitive support from WRA members. Bill asked for the EC’s input on what the WRA’s next steps should be. Tim suggested: 1) the WRA Board formally adopt the draft GSA proposal language in January; and 2) start the public forum process and determine how aggressively the Board wants to start asking the hard questions about topics such as the GSA’s function and what “sustainability” means to Yolo County. Tim said he is an advocate of the “incremental” approach. His sense is to start with a small group of invited guests/stakeholders since we are ahead of the deadline. In that forum, we can frame the subject and pose the pertinent questions that will need to be considered. A timeline should also be established for our process.

Bill shared his thoughts after he attended several ACWA conference groundwater legislation workshops. He feels it is important to have each of the participation agencies in this process adopt the planning proposal language to be sure everyone is in agreement. This would best be promoted with a preliminary informational groundwater presentation to each city council, the County Board, YCFCWCD Board and the Farm Bureau. This can be a short 15 minute presentation over a two month time period that should culminate in an action item for the elected body. The elected officials need to be informed and on-board before the invited public forum.

Tim mentioned that boundary definition is another important item to be clarified in coordination with the GSA formation. Indications are that Bulletin 118 boundaries will be used. One possible way to influence DWR’s decision would be if a group of stakeholders presented their preferred boundaries rather than meeting with DWR independently.

**6. FUNDING UPDATES:**

Jeanette Wrynski informed that the Yolo County RCD is looking to apply for an Urban Streams Restoration Grant. They are identifying partners to collaborate with as they have done with previous grants with the Putah Creek Council that garnered a lot of community engagement.

**7. WATER LEGISLATION & REGULATORY ISSUES UPDATE:**

- a) Delta updates: Nothing discussed.
- b) FloodProtect Update: Nothing discussed.
- c) Groundwater Legislation Update: Tim O'Halloran gave an update before leaving early for the press conference. The WRA TC and Board have been tracking the legislation process this year. The "Year of Groundwater" program (FY14-15 WRA projects) was organized in response to this process. The WRA is co-sponsoring this program with the Yolo County Farm Bureau. Activities in 2014 have been focused on education, which will transition into implementation next year as we prepare for upcoming mandated governance changes. Tim has been giving "Year of Groundwater" outreach presentations all around the county. One item that will need to be discussed is the formation of a Groundwater Sustainability Agency (GSA). A straw-poll at the last WRA Board meeting found that the majority of WRA member agencies were in agreement that the WRA is the mostly likely candidate to become the GSA, however it would require some changes to the WRA's structure to fit the legislation. It needs to be determined what authorities the WRA would have if it became the GSA. If not the WRA, then it would fall to Yolo County to form such an agency, in essence another WRA. Conversations will continue about these topics at the November 17<sup>th</sup> WRA Board meeting. Tentative letters of support will be solicited from the WRA's member agencies and other stakeholders regarding the intent to designate the WRA as the Yolo GSA. (Tim will work with Donna to develop a draft form letter for this purpose early next year.) Tim said that this process is being built up from a grassroots level with consideration that private well owners play an important role in the success of local groundwater legislation implementation (especially since private well owners aren't represented by the WRA).

Tim informed that there are two implementation paths for the groundwater legislation at the local level. If we can document with historical data that Yolo county has sustainable groundwater, then there won't be any difficult decisions to make and we can continue with our current strategies and methods for managing our groundwater. Tim believes that we are close to sustainable now and this winter could be a determining factor. If we determine that Yolo county does not have sustainable groundwater, then this will be the harder path and challenging decisions will need to be made. Do well owners need to be told turn their pumps off? Does adjudication need to be implemented? DWR will also be interpreting the meaning of "sustainable". The County of Yolo, the cities and the YCFC&WCD are the agencies that currently have groundwater management authorities of this nature, but the WRA does not. Tim reminded that the legislation deadline for implementation is 2017, but time passes quickly and it would benefit us to work diligently now toward that end. Tim will continue his educational outreach in November and December with several planned meeting presentations including the Irrigated Lands Program. Beginning in January 2015, the focus will shift to more decision-making discussions and specific stakeholder outreach. Tim reported that groundwater well levels are coming up after hitting bottom a month ago, which is good news!

- a) The Year of Groundwater (~\$62,500) – Updated given under item 7c. WRA’s 50% cost share for Mercury TMDL project will be taken from the \$70,000 available for this project.
- b) Westside IRWMP Implementation (\$20,000) – WRA’s cost share invoice pending receipt from SCWA.
- c) City of Winters Storm Water Mgmt. Planning (\$15,000) – Carol reported that work has not begun yet.
- d) Yolo Bypass Integrated Action (\$10,000) – ongoing stakeholder participation by YBWG/Robin Kulakow.
- e) Mercury TMDL Impacts & Implementation Assessment (\$15,000 WRA/City of Woodland cost share) – Update recently given by Stephen McCord at September WRA Board meeting.

**9. MEMBER INFORMATION & FUTURE AGENDA ITEMS:**

Elisa introduced an idea for the TC’s focus in 2015 related to the 2007 Yolo County IRWMP document as discussed by the WRA Executive Committee. Even though the Westside IRWMP is the current regional document, the Yolo IRWMP is still considered a living document and has useful information. The TC was asked to cull through the Yolo document, identify information that is still relevant and transform it into a working strategic plan for Yolo. There are also several new TC member representatives that are not as familiar with the Yolo IRWMP, so a review would benefit them.

Jeanette gave an update on the status of the Westside IRWM’s Brownfields Program grant application. Stephen McCord was approached by EPA staff who recommended that Yolo county consider applying for the grant. Stephen met with the Westside IRWM Coordinating Committee (CC) regarding a proposal for the Cache and Putah Creek watersheds to do an assessment of mercury contamination issues of old mining sites. Dr. McCord is proceeding to prepare an initial proposal that is due mid-December. The Westside CC will be reviewing information at their next several meetings. Donna reported that a letter of support from the WRA for the Westside’s grant proposal will be adopted at the November 17<sup>th</sup> Board meeting. Each of the Westside’s management entities will need to provide a letter of support.

Carol Scianna gave an update on the City of Winters’ investigations to comply with Chromium 6 MCL regulations and they are working with consultants to develop a plan. Elisa heard that the cities of Woodland and Davis set-up a meeting with CA Dept. of Public Health to request extending the compliance period pending the surface water project coming online in 2016. Carol also briefly discussed the City of Winters’ water recycling project.

Jeanette was asked about the Westside IRWMP’s process for adding new projects to the Plan. One of the responsibilities of the Westside Coordinating Committee (CC) is to annually update the status of all the projects that were submitted as part of the Plan. The Westside accepts new projects year round and there is a Project Information Form (available on their website: [www.westsideirwm.com](http://www.westsideirwm.com)) to fill-out for consideration by the CC. Elisa and Jeanette summarized the process for today’s newer meeting attendees. Basically any agency from all four counties that is looking for funding must submit their project to the Westside CC, because to be eligible for State funding the project must be part of the Westside IRWMP.

The City of Davis, RD 108 and YCFCWCD also gave brief updates on current activities. Donna announced that she will be contacting WRA members for their input on their 2014 grants and projects to highlight in the Annual Newsletter that she is preparing for distribution in January 2015.

Elisa asked if there are any topics of interest that the TC would like to cover or have a presentation given in 2015. Please give this information to Elisa or Donna.



#### Background

The WRA Technical Committee (TC) continues to focus on implementing Board priorities at their monthly meetings. A few of the TC's activities are highlighted below.

#### **WESTSIDE IRWMP**

The Westside IRWM Group is moving forward with their Drought Grant Award contracts with DWR. DWR reimbursed them for their grant application preparation expenses. In January the Coordinating Committee will be discussing the potential uses for this ~ \$90,000. The Westside submitted a proposal for the EPA's Brownfields Program grant with the assistance of Stephen McCord in December. The proposal is for an assessment of mercury contamination issues of old mining sites in the Cache and Putah Creek watersheds. There is no cost match requirement for this \$467,378 funding request. Award notifications anticipated in spring 2015.

#### **YOLO COUNTY IRWMP**

In 2015, the TC will begin a review of the Yolo IRWMP document. The review will familiarize newer TC member representatives with the Yolo County document. The TC will also evaluate the utility of its content to current planning and determine options to cull that information into a strategic plan for the Yolo region. The TC will also consider how the Yolo IRWMP's actions and priorities overlap with the Westside IRWMP, which is the current State recognized multi-county regional planning document.

#### **CA DEPT. of WATER RESOURCES UPDATES**

Kristin Honeycutt, Water Resources Engineer with the Division of Integrated Regional Water Management, provides monthly updates to the TC on IRWM programs and planning, grant funding opportunities, flood program and planning progress, and California Water Plan updates. DWR has established the Groundwater Information Center that includes an interactive map and information about the new groundwater legislation: <http://water.water.ca.gov/groundwater>. She also reported on the release of the State Water Board's Per Capita Data.
