



**Yolo Bypass Integrated Project  
End of Year Final Report  
July 1, 2015 – June 30, 2016**

The **Yolo County Integrated Resource Water Management Plan** is composed of a set of water related projects loosely grouped by watershed. For purposes of the Yolo County IRWMP, projects in the Yolo Bypass are called the **Yolo Bypass Integrated Project (YBIP)**. Since Fiscal Year 2007-08, **Yolo Basin Foundation** has been under contract with the **Yolo County Water Resources Association** to serve as the facilitating entity for the YBIP.

In the past 12 months there has been progress in bringing forward the concept of integrated planning for the Yolo Bypass. This integration is happening at the local level through Yolo County's participation in numerous ways. At the Regional level there is the regional Flood Management Plan Project Development Team. At the state level, Kris Tjernell, Special Assistant for Water Policy at the CA Resources Agency (CNRA), is working with the multiple state and federal agencies while being in close communication with local stakeholders. Yolo Basin Foundation is working closely with representatives from the three levels of government plus keeping in communication with farmers and wetland managers and agency staff from Department of Water Resources (DWR), Department of Fish and Wildlife (DFW), US Army Corps of Engineers (USACOE) and US Bureau of Reclamation (USBOR).

During the FY 2015-2016 Yolo Basin Foundation organized and facilitated two Yolo Bypass Working Group meetings with the following agenda items:

December 8, 2015 – What's up for the Yolo Bypass in 2016, attended by 28 stakeholders.

1. Integrating Flood protection and fisheries habitat improvements (conceptual ideas and modeling efforts)
2. Drainage and Infrastructure Improvements (Proposition 1 grant proposals)
3. Eco Restore projects in the Yolo Bypass
4. USACOE Sacramento River Flood Control Project Reauthorization (GRR)
5. Yolo Bypass Wildlife Area update

May 24, 2016 – Attended by 42 stakeholders
